**RESOLUTION No. 49 series of 2018**

**WHEREAS**, Cebu Normal University posted an Invitation to Bid for the procurement of One Lot Office Supplies (4<sup>th</sup> Quarter) with Bid No. 18-09-1026 with an Approved Budget for the Contract of One Million Five Hundred Eighty-Six Thousand Three Hundred Forty Pesos (Php 1,586,340.00) in the PhilGEPS and in a conspicuous place at the premises of Cebu Normal University;

**WHEREAS**, OfficeBox Enterprises submitted the lowest calculated bid in the amount of One Million Three Hundred Sixty-Seven Thousand Five Hundred Twenty-Six Pesos (Php 1,367,526.00);
