**RESOLUTION No. 50 series of 2018**

**WHEREAS**, Cebu Normal University posted an Invitation to Bid for the procurement of One Lot IT Supplies and Consumables (4<sup>th</sup> Quarter) with Bid No. 18-09-1027 with an Approved Budget for the Contract of One Million Seven Hundred Ninety-Six Thousand Three Hundred Fifty-Four Pesos and Twenty-Six Centavos (Php 1,796,354.26) in the PhilGEPS and in a conspicuous place at the premises of Cebu Normal University;

**WHEREAS**, OfficeBox Enterprises submitted the lowest calculated bid in the amount of One Million Six Hundred Eight Thousand One Hundred Forty-Nine Pesos (Php 1,608, 149.00);

**WHEREAS**, per BAC Resolution No. 46 series of 2018 dated October 31, 2018, OfficeBox Enterprises was declared post-qualified;

**WHEREAS**, OfficeBox Enterprises submitted the post-qualification requirements on time;

**WHEREAS**, OfficeBox Enterprises was compliant to all the requirements; hence, responsive;


**NOW THEREFORE**, we, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is **RESOLVED**:
