**BAC Resolution Declaring the Lowest Calculated Responsive Bidder (LCRB)
and Recommending Approval and Award**

RESOLUTION No. 42 series of 2019

WHEREAS, Cebu Normal University posted an Invitation to Bid for the procurement of One Lot ICT Parts and Accessories with Bid No. 19-07-561 with an Approved Budget for the Contract of One Million Seven Hundred Ninety-Nine Thousand Five Hundred Pesos (Php 1,799,500.00) in the PhilGEPs, in the CNU website and in a conspicuous place at the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 39 series of 2019 dated November 4, 2019 declared the bid of Perfect Star PC Shoppe the Lowest Calculated Bid (LCB) in the amount of One Million Seven Hundred Seventy-Three Thousand Six Hundred Twenty-Four Pesos and Twenty-Five Centavos (Php 1,773,624.25);

WHEREAS, Section 34.4 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 states that: *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HOPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."*

WHEREAS, the submitted bid price of Perfect Star PC Shoppe which is One Million Seven Hundred Seventy-Three Thousand Five Hundred Forty-Seven Pesos and Eighty Centavos (Php 1,773,547.80) is lower than the calculated bid price; hence, is the amount recommended for award;

WHEREAS, Perfect Star PC Shoppe was compliant to the eligibility requirements and submitted the documents as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on time;

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group found the bid of Perfect Star PC Shoppe compliant; hence, declared post-qualified and responsive for the procurement of One Lot ICT Parts and Accessories with Bid No. 19-07-561;

WHEREAS, upon review of the Bids and Awards Committee and the Technical Working Group of the unit prices of all the items comprising the One Lot ICT Parts and Accessories, the following items have exceeded the Fifteen Thousand Pesos (Php15,000.00) threshold to be considered in this lot because they are already categorized as equipment:

WHEREAS, the abovementioned items with a total amount of Four Hundred Sixty-Six Thousand One Hundred Fourteen Pesos (Php 466,114.00) cannot be included in the award of the One Lot ICT Parts and Accessories; hence, recommended for deduction in the amount of the contract for award due to funding constraints;

WHEREAS, the financial proposal of Perfect Star PC Shoppe in the amount of One Million Seven Hundred Seventy-Three Thousand Five Hundred Forty-Seven Pesos and Eighty Centavos (Php 1,773,547.80) minus the amount of Four Hundred Sixty-Six Thousand One Hundred Fourteen Pesos (Php 466,114.00), which is equivalent to One Million Three Hundred Seven Thousand Four Hundred Thirty-Three Pesos and Eighty Centavos (Php 1,307,433.80) is the amount to be awarded in the procurement of One Lot ICT Parts and Accessories with Bid No. 19-07-561;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare Perfect Star PC Shoppe as the Lowest Calculated Responsive Bidder (LCRB) in the procurement of One Lot ICT Parts and Accessories with Bid No. 19-07-561; and
- b) To recommend for approval by the President of Cebu Normal University the foregoing findings and to award the contract to **Perfect Star PC Shoppe** in the amount of **One Million Three Hundred Seven Thousand Four Hundred Thirty-Three Pesos and Eighty Centavos (Php 1,307,433.80)**.
