**BAC Resolution Declaring the Lowest Calculated Responsive Bidder (LCRB)
and Recommending Approval and Award**

RESOLUTION No. 40 series of 2019

WHEREAS, Cebu Normal University posted an Invitation to Bid for the project One Lot Proposed CNU Balamban Campus Canteen with Bid No. 19-09-700 with an Approved Budget for the Contract of One Million Pesos (Php 1,000,000.00) in the PhilGEPS, in the CNU website and in a conspicuous place at the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 36 series of 2019 dated October 29, 2019 declared the bid of Petrina Construction and General Merchandising the Lowest Calculated Bid (LCB) in the amount of Nine Hundred Sixty-Three Thousand Four Hundred Seventy-One Pesos and Twelve Centavos (Php 963,471.12);

WHEREAS, Section 34.4 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 states that: *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HOPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."*

WHEREAS, the submitted bid price of Petrina Construction and General Merchandising which is Nine Hundred Sixty Thousand Nine Hundred Seventy-Two Pesos and Twelve Centavos (Php 960,972.12) is lower than the calculated bid price; hence, is the amount recommended for award;

WHEREAS, Petrina Construction and General Merchandising was compliant to the eligibility requirements and submitted the documents as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on time;

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group found the bid of Petrina Construction and General Merchandising compliant; hence, declared post-qualified and responsive for the project One Lot Proposed CNU Balamban Campus Canteen with Bid No. 19-09-700;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare Petrina Construction and General Merchandising as the Lowest Calculated Responsive Bidder (LCRB) in the project One Lot Proposed CNU Balamban Campus Canteen with Bid No. 19-09-700; and
