

Contract Agreement Form

THIS AGREEMENT made the 7th day of August 2017 between **Cebu Normal University** of the Philippines ("the Procuring Entity") of the one part and **Sentinel Plastic Manufacturing Corporation** of 404 M. H. Del Pilar St. Maysilo Malabon City 1477 ("the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of the 500 Pieces Plastic Tablet Classroom Armchair with Bid No. 17-05-224** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Four Hundred Forty Thousand Pesos only (Php1,440,000.00)** ("the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part this Agreement, viz:
 - (a) the Supplier's Bid, including Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of the Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provisions of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.






