One Lot Completion of the CNU – Balamban Perimeter Fence

1. The Cebu Normal University, through the General Appropriations Act of 2016 (continuing) intends to apply the sum of **One Million Nine Hundred Forty-Nine Thousand Nine Hundred Eleven Pesos and Eighty-Five Centavos (Php 1,949,911.85)** being the Approved Budget for the Contract (ABC) to payments under the contract for the project **One Lot Completion of the CNU – Balamban Perimeter Fence with Bid No. 17-09-595**. Bids received in excess of the ABC shall be automatically rejected upon bid opening.
2. The Cebu Normal University now invites bids for the project One Lot Completion of the CNU – Balamban Perimeter Fence with 333.95 linear meters.

Description

1. Excavation Works
2. Concrete Works
3. Masonry Works
4. Rebar Works
5. Formworks and Scaffolding
6. Steel Works
7. Painting Works (Gate)


Completion of the works is required within Eighty (80) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Cebu Normal University and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested bidders on October 9 - 27, 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Pesos (Php 2,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Cebu Normal University will hold a Pre-Bid Conference on October 16, 2017, 2:00 o'clock in the afternoon at the BAC Office, Room 203, 2/F Administration Building, Cebu Normal University, Osmeña Boulevard, Cebu City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 2:00 o'clock in the afternoon of October 30, 2017. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bid Opening shall be on October 30, 2017, 2:00 P. M. at the BAC Office, Room 203, 2/F Administration Building, Cebu Normal University, Osmeña Boulevard, Cebu City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The Cebu Normal University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
