**BAC Resolution Declaring Single Calculated Responsive Bid (SCRB)  
and Recommending Approval**

**RESOLUTION No. 59 series of 2018**

**WHEREAS**, Cebu Normal University posted an Invitation to Bid for the procurement of One Lot Audio Visual Upgrade for the 7<sup>th</sup> Floor Teaching Arts Centrum with Bid No. No. 18-10-1202 with an Approved Budget for the Contract of One Million Pesos (Php 1,000,000.00) in the PhilGEPS and in a conspicuous place at the premises of Cebu Normal University;

**WHEREAS**, per BAC Resolution No. 52 series of 2018 dated December 6, 2018, Lyric Piano and Organ Corp., the lowest bidder as read, was declared disqualified for non-compliance to the required Two (2) Units Dynamic Vocal Wired Microphone as specified in the Bid Data Sheet and Technical Specifications of the Bidding Documents;

**WHEREAS**, Microdata Systems and Management, Inc., the second lowest bidder as read, was compliant to all the required items and technical specifications;

**WHEREAS**, Microdata Systems and Management, Inc. is the single calculated bidder in the amount of Nine Hundred Ninety-Eight Thousand Four Hundred Fifty-Five Pesos (Php 998,455.00);

**WHEREAS**, Microdata Systems and Management, Inc. was declared post-qualified per BAC Resolution No. 57, series of 2018 dated December 21, 2018;

**WHEREAS**, Microdata Systems and Management, Inc. submitted the post-qualification requirements on time;

**WHEREAS**, Microdata Systems and Management, Inc. was compliant to all the requirements; hence, responsive;

**NOW THEREFORE**, we, the members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED:
