WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of ICT Equipment and Accessories with Bid No.19-03-178 in three (3) lots with a total Approved Budget for the Contract of Two Million Eight Hundred Sixteen Thousand Nine Hundred Six Pesos and Fifty-Six Centavos (Php 2,816,906.56) in the PhilGEPS, in the CNU website and in a conspicuous place at the premises of Cebu Normal University;

WHEREAS, the three (3) lots of this procurement which a prospective bidder can submit partial bid/s are the following with the corresponding Approved Budget for the Contract (ABC):

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group found the bid of DJ PCWise Corporation compliant; hence, declared post-qualified and responsive for the One Lot Computer Equipment and Accessories (Lot 1);

**NOW THEREFORE,** we the Members of the Bids and Awards Committee, hereby RESOLVE as it hereby RESOLVED:

- a) To declare DJ PCWise Corporation as the Lowest Calculated Responsive Bidder in the One Lot Computer Equipment and Accessories (Lot 1)) in the bidding for the project Procurement of ICT Equipment and Accessories with Bid No.19-03-178.
