RESOLUTION No. 53 series of 2019

WHEREAS, Cebu Normal University posted an Invitation to Bid for the **Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2020 with Bid No. 19-10-828** with an Approved Budget for the Contract of **Five Million Two Hundred Seventy Thousand Fifty-Eight Pesos and Four Centavos (Php 5,270,058.04)** in the PhilGEPS, in the CNU website and in a conspicuous place at the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 48 series of 2019 dated December 12, 2019 declared the bids of **Helpmate Services, Inc.** and **CBII Philippines International, Inc.**, both with the same amount of **Five Million Two Hundred Seventy Thousand Fifty-Eight Pesos (Php 5,270,058.00)**, as the Lowest Calculated Bids (LCB);

WHEREAS, BAC Resolution No. 52 series of 2019 dated December 23, 2019 declared **Helpmate Services, Inc.**, **post-disqualified**;

WHEREAS, **CBII Philippines International, Inc.** was compliant to the eligibility requirements and submitted the documents as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on time;

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group found the bid of **CBII Philippines International, Inc.** compliant; hence, declared post-qualified and responsive for the Procurement of **One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2020 with Bid No. 19-10-828**;


NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:




