BAC Resolution Declaring the Lowest Calculated Responsive Bidder (LCRB) and Recommending Approval and Award

RESOLUTION No. 15 series of 2020

- WHEREAS, Cebu Normal University posted an Invitation to Bid for the project One Lot Completion of Library Modernization (3rd Level) with Bid No. 20-02-110 with an Approved Budget for the Contract of Fourteen Million Nine Hundred Thirty-seven Thousand Eighteen Pesos and Seventy-three Centavos (Php 14,937,018.73) in the PhilGEPS, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;
- WHEREAS, BAC Resolution No. 11 series of 2020 dated June 2, 2020 declared the bid of Charlz Construction as the Lowest Calculated Bid (LCB);
- WHEREAS, Charlz Construction was compliant to the eligibility requirements and submitted the documents as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on time;
- WHEREAS, after the Post-Qualification Evaluation process, the members of the Bids and Awards Committee and the Technical Working Group found the bid of Charlz Construction compliant; hence, declared post-qualified and responsive for the project One Lot Completion of Library Modernization (3rd Level) with Bid No. 20-02-110;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare Charlz Construction as the Lowest Calculated Responsive Bidder (LCRB) in the project One Lot Completion of Library Modernization (3rd Level) with Bid No. 20-02-110; and
- b) To recommend for approval by the Board of Regents of Cebu Normal University the foregoing findings and to award the contract to Charlz Construction in the amount of Fourteen Million One Hundred Seventy Thousand Five Hundred Eleven Pesos and Fourteen Centavos (₱ 14,170,511.14).
