BAC Resolution Declaring the Lowest Calculated Responsive Bidder (LCRB) and Recommending Approval and Award

RESOLUTION No. 28 series of 2020

- WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot Office Supplies for Modular Learning Scheme for AY 2020 2021 with Bid No. 20-08-247 with an Approved Budget for the Contract of Nine Hundred Three Thousand Six Hundred Fifty Pesos (Php 903,650.00) in the PhilGEPS, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;
- WHEREAS, BAC Resolution No. 26 series of 2020 dated September 2, 2020 declared the bid submitted by Trimax Computer Supplies and General Merchandise as the Lowest Calculated Bid (LCB);
- WHEREAS, Trimax Computer Supplies and General Merchandise was compliant to the eligibility requirements and submitted the documents on time as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
- WHEREAS, upon careful examination, validation and verification of all the eligibility documents, financial proposal, technical specifications and post-qualification documents submitted, the Technical Working Group declared Trimax Computer Supplies and General Merchandise post-qualified; hence, responsive in the Procurement of One Lot Office Supplies for Modular Learning Scheme for AY 2020 2021 with Bid No. 20-08-247;
