- WHEREAS, the Cebu Normal University posted an Invitation to Bid for the Procurement of Module Production for Second Semester of AY 2020 2021 with Bid No. 20-10-380 in the PhilGEPS website, in the website of Cebu Normal University and in a conspicuous place within the premises of Cebu Normal University with an Approved Budget for the Contract of Three Million Nine Hundred Ninety Thousand Pesos (Php 3,990,000.00);
