RESOLUTION No. 11 series of 2021

- WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2021 (Re-Bid) Bid No. 20-11-437 with an Approved Budget for the Contract of Five Million Five Hundred Ten Thousand Nine Hundred Sixteen Pesos (Php 5,510,916.00) in the PhilGEPS, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;
- WHEREAS, BAC Resolution No. 9 series of 2021 dated January 6, 2021 declared the bid of CBII Philippines International, Inc., in the amount of Five Million Five Hundred Ten Thousand Nine Hundred Sixteen Pesos (Php 5,510,916.00)as the Lowest Calculated Bid (LCB);
