BAC Resolution Recommending for Cancellation in the Bidding of the Procurement of One Lot Internet Connectivity Kit and Devices and Conduct New Bidding

RESOLUTION No. 56 series of 2021

- WHEREAS, the Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot Internet Connectivity Kit and Devices with Bid No. 21-07-382 in the PhilGEPS website, in the website of Cebu Normal University and in a conspicuous place within the premises of Cebu Normal University with an Approved Budget for the Contract of One Million Fifty Thousand Pesos (Php 1,050,000.00);
- WHEREAS, the following prospective bidders submitted Letters of Intent and their representatives attended the Pre Bid Conference conducted online via ZOOM Platform on August 13, 2021; to wit:
 - 1. Innove Communications; and
 - 2. Spring Development Inc.;
- **WHEREAS**, in the conduct of the Pre-Bid Conference, concerns pertaining to the specifications of the items to be procured were identified;
- WHEREAS, after the conduct of the pre-bid conference, the TWG/End-User sent a letter request to the BAC through the BAC Chair notifying of the changes in the specifications and specifying the quantity of the items under the lot and further request for the readvertisement due to change in the specifications, additional of quantity under the lot and change in the Approved Budget for the contract;
- WHEREAS, Section 35.6 of the Implementing Rules and Regulation of the Republic Act 9184 authorizes the BAC to cancel or terminate the conduct of procurement activities for a justifiable reason. Section 35.6 provides,
 - 35.6 Without prejudice to Sec. 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to: a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit; xxx
- WHEREAS, the present circumstance of the above-mentioned procurement falls squarely on the above-cited provision. There will be material change in the specifications of the items to be procured. Should the current procurement activity will proceed, it will thereafter declare failure since no supplier can comply with the specifications provided because the particular item required is not available in the market and there is a need to add exact location of users in order to determine the availability of a particular network therein and

this move is further adopted to save time, effort and expense for the procuring entity and that of the prospective bidders.

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To recommend for the cancellation of the Purchase Request and Requisition Form and revise in accordance with the correct specifications and it is further recommended that end-users shall revise their respective Purchase Request and Requisition Form; and
- b) To Cancel the Current Procurement Activity and to Conduct New Bidding for the Procurement of One Lot Internet Connectivity Kit and Devices.
